After evaluation of price bid of all 11 bidders, the price bid report and status of contract award to the successful bidder is appended below:

After evaluating the price bid of all the qualified bidders, it was found that total 06 bidders were declared as qualified bidders and rest 05 bidders as disqualified bidders due to reasons mentioned in price bid report. Also it was clearly evident from the price bid report that total 03 bidders were at L-1 position as per their quoted rates. In order to select the lowest bidder among the 03 L-1 bidders, the committee resolute that the bidder which had high turnover/higher experience will be awarded with the contract for providing security services at RGIPT as mentioned in para 4 (I) of tender document whereas clearly stated that ***in case of more than L-1 bidder (price bid), the agency with higher experience/ high turnover will be awarded.***

The turnover report of last 03 financial year, submitted by the L-1 bidders duly ratified by CA along with the firm incorporation date is appended below:
