#### **INSTRUTION FOR ONLINE BID SUBMISSION**

The bidders are required to submit soft copies of their bids electronically on the e-tender Portal, using valid class 3 Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the e-tender Portal, prepare their bids in accordance with the requirements and submitting their bids online on the e-tender Portal.

More information useful for submitting online bids on the e-tender Portal may be obtained at: https://rgipt.euniwizarde.com.

#### REGISTRATION

**1.** Bidders are required to enroll on the e-Procurement Portal (URL: https://rgipt.euniwizarde.com) with clicking on the link "Online bidder Registration" on the e-tender Portal by paying the **Registration fee of Rs. 2360/- Per vendor/per year.** 

2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.

3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication with the bidder.

4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate **(Only Class III Certificates with signing + encryption key usage)** issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.

5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.

6. Bidder then logs in to the site through the secured log-in by entering their user ID /password and the password of the DSC / e-Token.

7. The scanned copies of all original documents should be uploaded on portal https://rgipt.euniwizarde.com

#### **SEARCHING FOR TENDER DOCUMENTS**

1. There are various search options built in the e-tender Portal, to facilitate bidders to search active tenders by several parameters.

2. Once the bidders have selected the tenders they are interested in, you can pay the form fee and processing fee (NOT REFUNDABLE) by net-banking / Debit / Credit card then you may download the required documents / tender schedules, Bid documents etc. Once you pay both fee tenders will be moved to the respective 'requested' Tab. This would enable the e-tender Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.

#### **PREPARATION OF BIDS**

1. Bidder should take into account any corrigendum published on the tender document before submitting their bids.

2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid.

3. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF formats. Bid Original documents may be scanned with 100 dpi with Colored option which helps in reducing size of the scanned document.

4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents **(e.g. PAN card copy, annual reports, auditor certificates etc.)** has been provided to the bidders. Bidders can use "My Documents" available to them to upload such documents.

5. These documents may be directly submitted from the "My Documents" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### **SUBMISSION OF BIDS**

1. Bidder should log into the website well in advance for the submission of the bid so that it gets uploaded well in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.

2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document as a token of acceptance of the terms and conditions laid down by RGIPT, Jais.

3. Bidder has to select the payment option as **"e-payment" to pay the tender fee / EMD** as applicable and enter details of the instrument.

4. Bidders are requested to note that they should necessarily submit their price bid (financial bids) in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the white Colored (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

5. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.

6. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.

7. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.

8. Upon the successful and timely submission of bid click "Complete" (i.e. after Clicking "Submit" in the portal), the portal will give a successful Tender submission acknowledgement & a bid summary will be displayed with the unique id and date & time of submission of the bid with all other relevant details.

9. The tender summary has to be printed and kept as an acknowledgement of the submission of the tender. This acknowledgement may be used as an entry pass for any bid opening meetings.

- 8. The offer of the tenderer shall be valid for 6 (Six) months from the date of opening of the Technical Bid of the Tender.

#### 2. Eligibility Criteria

- 1. The EMD of Rs. 40,000/- (Rs. Forty Thousand only) through e-payment gateway available on https://rgipt.euniwizarde.com. The tenderers shall be required to attach proof of e payment of EMD.
- 2. The following documents must be submitted along with the Tender Document.

The brand and model name of the offered item should be mentioned clearly in the technical compliance sheet.
- **4. Price Reasonability Certificate** should be enclosed on letter head of the firm in given format with tender document as **Annexure 2.**
- 5. The bidder should attach annual turnover of the firm for last three years (please enclose documentary evidence such as certificate given by the Chartered Accountant).
- 6. The bidder should have minimum Three (3) year of experience for supply and installation of Gym and Sports equipment. Purchase orders issued with the name of firm/company should be attached with tender document.
- 7. Bank detail of firm/cancelled cheque.
- 8. Entire tender document duly signed and stamped by the bidder.

#### 3. EMD (Earnest Money Deposit)

The EMD should be paid only in online mode on https://rgipt.euniwizarde.com for **Rs. 40,000/- (Rupees Forty Thousand only)**. No interest shall be paid on earnest money deposited.

The EMD of the unsuccessful bidders will be returned after final award of the Job to a successful bidder/ acceptance of the tender and within reasonable time not exceeding six months from the date of opening of tender. The EMD will carry no interest.

The EMD will be forfeited if the bidder withdraws his offer before finalization of the tender.

The EMD of successful bidder will be returned after submission of Performance Security.

Micro or Small Enterprises registered with National Small Industries Corporation or any other body specified by ministry of Micro, Small & Medium Enterprises are entitled to exemption from submitting EMD, subject to submission of valid certificate of MSME/NSIC.

#### 4. Evaluation Criteria

The order will be awarded to the vendor, who fulfills all the technical specifications & conditions mentioned in the tender document for Technical Bid and which is overall L1 in Financial Bid. Evaluation of Lowest bid will be calculated on the total price of all items tendered for basic equipment along with accessories, packing & forwarding, installation & commissioning, GST and other charges etc. as mentioned in the tender **(Bidder must submit the technical bid & financial bid separately)**. The Financial bid will be opened only of those firms, who will be found technically qualified after evaluation of their technical bids.

#### 5. Bid Validity

The Bid must be valid for 180 days from the date of opening of Technical Bid. No tenderer will be allowed to withdraw his tender after submission during the bid validity period (6 months). In case the tenderer does not honour his bid, the EMD submitted by the tendering firm would stand forfeited. In case the successful Tenderer declines the offer of contract, for whatsoever reason(s), his EMD will be forfeited.

#### 6. Price Validity

The price quoted by the bidder shall remain valid till the supply and installation is completed. During the tenure of the supply and installation period, no price increase will be considered, except for change in statutory levies imposed by Centre Govt. / state Govt. or local authorities

#### 7. Payment Terms

100% payment will be released after successful supply and installation of all Gym Equipment at site, i.e. Rajiv Gandhi Institute of Petroleum Technology Jais, Amethi- 229 304 and subject to the satisfaction of The Dean, Students' Affairs and submission of original GST Invoice as certified by the Indenter.

#### 8. Warranty

Warranty in respect of all items for a period of minimum **Two Year** is required. Warranty period will start from the date of installation of the respective equipment.

#### 9. Performance Security

The successful bidder will provide "Performance Security" for an amount of 5% of the contract value in the form of valid Demand Draft from a nationalized bank in favour of "Rajiv Gandhi Institute of Petroleum Technology" payable at Jais, Amethi. The Performance Security should be kept with RGIPT for a period of 180 days beyond the date of completion of all contractual obligations of supplier. Thereafter the security will be returned, provided there is no defect in the equipment supplied. The Institute will not be liable to pay any interest on performance security submitted.

#### **10. Delivery and Installation**

Supply and installation shall be completed within 15 Days from the issue of the Purchase Order.

#### **11. Liquidated Damages (LD)**

In case, any delay in supply and installation of Gym & Sports Equipment, the liquidated damages at the rate 0.50% of the order value per day of delay or part there of subject to a maximum of 5 % of the order value shall be recovered from the contractor.

If it is found that, any defective equipment has been supplied, it should be replaced by the vendor on his own cost within 7 days of notice of the same.

In case the supplier has failed to complete the order/project within the stipulated time, Institute reserves the right to cancel the contract/order and performance security/EMD may be forfeited.

#### 12. Experience

The vendor should possess a good and sound experience of minimum Three years in similar class of business (Supply and installation of Gym & Sports Equipment) in any Central Govt./PSU/Autonomous body/ State Govt.
