INTRODUCTION

Rajiv Gandhi Institute of Petroleum Technology, Jais Amethi has been set up by the Ministry of Petroleum and Natural Gas as an "Institute of National Importance" along the lines of IIT's under an Act of Parliament. RGIPT is co-promoted as an energy domain specific institute by six leading Oil Public Sector Units (ONGC, IOCL, OIL, GAIL, BPCL and HPCL) in association with the Oil Industry Development Board (OIDB). The Institute is associating with leading International Universities/Institutions specializing in the domain of Petroleum Technology.

RGIPT Jais is situated on Rae Bareli – Sultanpur National Highway, Near Jais Railway Station at a distance of 27 km from Rae Bareli. The nearby Nagar Palika is Jais, which has a periphery of around 2.5 Kms.

NOTICE INVITING TENDER

Sealed tenders are invited for supply of Miscellaneous Painting Items at Rajiv Gandhi Institute of Petroleum Technology Jais, Amethi. The Bidder is expected to enclosed photocopies of the documents as asked in 'Annexure – A, submit the Price Reasonability Certificate on letterhead of the firm/company as Annexure - B and must quote their rates in given format for mentioned brands only, as mentioned in 'Annexure – C'. It is responsibility of the bidders to quote for each item as asked in the tender document. In case, it is found that the bidder has not quoted the rate according to the mentioned brand or has quoted the rates for any other brand or has not quoted for each and every item respectively, the tender of the respective bidder will not be considered for financial evaluation.

Bidders are required to submit 'Earnest Money Deposit' (EMD) of Nationalized Bank, in the form of Demand Draft, for an amount of Rs. 11,000/- in favour of 'Rajiv Gandhi Institute of Petroleum Technology' payable at 'Jais, Amethi'. In case, the tender is submitted without EMD, the tender will be summarily rejected without assigning any reason thereof. The EMD(s) of unsuccessful bidders will be returned after finalization of tender process without any interest. The EMD of L1 Bidder shall be returned after successful supply of the items to the satisfaction of Engineer In-charge and final settlement of the bill amount. No interest will be paid on EMD amount.

The quoted rate shall be inclusive of all taxes & freight etc. and shall remain firm till the finalization of the tender. The L1 bidder has to submit original invoice after successful supply of items at RGIPT Jais campus to the satisfaction Engineer In-charge. Billing of L1 bidder will be done as per GSTIN Act by mentioning HSN Code of each item in the Invoice/Bill. The payment will be made either by Account Payee Cheque or through RTGS/NEFT after making the statutory deduction like TDS etc.

The quotation should be in sealed envelope and super scribed with **"Tender Reference No. RGIPT/JAIS/Misc Painting Items/Tender/2021-22/01 dated 09.09.2021,** Tender for Supply of Miscellaneous Painting Items.

RGIPT reserves the right to amend or withdraw any of the terms and conditions contained in the bid document or to reject the tender without giving any notice or assigning any reason. The decision of The Chairman, Institute Works Committee in this regard shall be final and binding on all.

ELIGILIBILITY CRITERIA
