## PRE-QUALIFICATION OF PRECAST CIVIL CONTRACTORS FOR CONSTRUCTION OF TEMPORARY FACILITIES AT KAMBALIPURA, BANGALORE.

### 1. GENERAL

Rajiv Gandhi Institute of Petroleum Technology (RGIPT), has been set up by the Ministry of Petroleum & Natural Gas, through an Act of Parliament as an autonomous "Institute of National Importance". A Bangalore Centre of RGIPT, ENERGY INSTITUTE, BANGALORE is being established in Kambalipura, Hosakote Taluk essentially for imparting higher education in field of energy. The prime objective of the Institute is to provide world class education, training, and research to roll out efficient human resources to meet the growing requirements of the Petroleum & Energy sector.

For setting up of the Institute, a land of 150 acres has been allotted to RGIPT by Government of Karnataka in Kambalipura, Hosakote Taluk. While construction of this Centre of Excellence in Kambalipura land would require a 2 to 3 years, academic sessions would begin from the year 2019-20 from temporary facilities at the same site. The temporary facilities include buildings for an academic block, and hostels for boys and girls & allied facilities

Contractors applying for pre-qualification must fulfill each of the following criteria individually as construction contractor/contracting firm. The applications of the contractors not fulfilling the said criteria shall not be considered for short listing /pre-qualification.

- ✓ The applicant should be experienced in the field of construction /execution of above mentioned building works during the last 7 (seven) years ending last day of the month previous to the one in which applications are invited.
- ✓ The applicant should have a valid PAN of Income Tax Department & registration under GST.
- ✓ The applicant shall have experience of having successfully completed building works similar to the proposed project during last 7 (seven) years ending 31st March - 2018 as per the following eligibility criteria:
- ✓ Requirement of solvency, value of work executed and Annual Turnover is as under: -The applicant's average annual financial turnover (construction work only) during the last 3 (three) years ending 31<sup>st</sup> March, 2018 should be at least Rs 5.00 crores.
- ✓ Applicants shall have experience of having successfully carried out and completed similar work during the last 7 years ending last day of the month previous to the one in which applications are invited, which experience should be any one of the following:
  - Three similar completed works, each costing not less than Rs 6.60 crore
  - Two similar completed works, each costing not less than the amount Rs 8.25 crore
  - One similar completed work costing not less than Rs 13.20 crore
- ✓ Proof in the form of a letter/certificate, issued by authorized personnel of respective clients for having successfully completed similar work, must be submitted and bids received without such a letter/certificate of successful completion specifying the value of work shall be summarily rejected and no further correspondence shall be entertained
- ✓ Vendors / contractors with negative net worth will not be considered barring PSUs approved by PMC and / or RGIPT.
- ✓ The working capital requirement can be fulfilled by –

- a) The firm must be registered/ have executed similar works in appropriate class / category with CPWD / MES / PSU / Oil PSUs/Nationalized Banks / PWD / Railways / Other Govt. & Semi Govt. Organizations / Construction firms of National or International repute.
- b) The firm must have adequate experienced Civil Engineer/s (with at least 03 years for Civil Engg Degree holder and 05 years for Civil Engg. Diploma Holders); supervisors with at least 03 years of relevant experience, currently employed with the firm for not less than the last 5 years.
- c) The firm to be in possession of concrete mixer with hopper; weigh batcher; cube moulds; moisture testing, silt content, volumetric & weight measuring, sieve analysis and other equipment required to set up a field laboratory, along with relevant IS Codes.
- d) The firm shall with his application submit the latest Bank Solvency Certificate (from Nationalized or Scheduled Bank) as mentioned above.
