1. Scope of work: Procurement of 1 No. Maruti Suzuki Ertiga-7 Seater (VXI, Petrol Variant, Pearl Arctic White) and 1 No. Maruti Suzuki Dzire-5 Seater (VXI, Petrol Variant, Arctic White color) in Rajiv Gandhi Institute of Petroleum Technology, Jais Amethi- 229304 as per specifications mentioned in Annexure I & II through two bid system. The Technical and Financial bids must be submitted in two separate sealed envelopes super scribed as Technical and Financial bid on the envelops and these two envelopes must be kept under one sealed envelope.

#### 2. Eligibility Criteria:

- a. The bidder must be either OEM/ Authorized Dealer/ Authorized Distributor of Maruti Suzuki India Limited. The copy of authorization letter must be enclosed with the tender.
- b. The bidder must have valid GST & PAN Number. The copy of relevant document must be enclosed.
- c. EMD of Rs.1,00,000/- must be submitted in the form of DD in favour of RGIPT.
- d. The bidder must comply the technical specification as mentioned in the bid.
- e. The bidder must have three years of experience for selling of Maruti Vehicles as a dealer/distributor/ OEM.
- f. The bidder must not be black listed by any Government Department etc. A self-declaration certificate must be enclosed.
- g. The bidder must have Annual Turnover of not less than 25 lakh for last three years. The CA certified Annual Turnover Certificate must be enclosed.

#### 3. Evaluation of Bids: The bids will be evaluated in two steps. (Technical and Financial)

#### a. The tender will be evaluated on item wise basis.

- b. The bids of eligible bidders only will be evaluated based on eligibility criteria mentioned in the tender document.
- c. The bidders whose technical bid is found to meet both the requirements as specified above will qualify for opening of the financial bid.
- d. The duly constituted Purchase Committee shall evaluate the bids. The Purchase Committee shall be empowered to take appropriate decisions on minor deviations, if any.
- e. The bidder's name, bid prices, discounts and such other details considered as appropriate by RGIPT, Jais, Amethi, will be announced at the time of opening of the financial bids.
- f. The bids shall be evaluated on the basis of the total prices including all taxes

and duties as per the details mentioned in the financial bid.

#### 4. TERMS AND CONDITIONS OF THE TENDER

#### a. Location of Supply & Installation of Vehicle & Warranty Services:

- b. All the items covered in the Schedule of Requirements must be supplied within 16 weeks from the date of placement of purchase order.
- c. The successful bidder has to submit performance security of 10% of the contract value in the form of DD/FDR/BG from any recognized bank which should be valid beyond 60 days of completion of the warranty period.
- d. A bid submitted with false information will not only be rejected but the vendor may also be debarred for participation in future tendering processes.
- e. Authorized representative may choose to be present at the time of opening of quotationat their own cost.
- f. Only one PRICE BID should be submitted for the above equipment. A bidder who submits more than one PRICE BID, shall be disqualified and considered non- responsive.

#### **5.** Amendment to Bidding Documents:

- ii. At any time prior to the deadline for submission of bids, RGIPT, Jais, Amethi may, for any reason, whether on its own initiative or in response to the clarification request by a prospective bidder, modify the bid document.
- iii. The amendments to the tender documents, if any, will be notified by release of Corrigendum Notice on institute website against this tender. The amendments/ modifications will be binding on the bidders.
- iv. RGIPT, Jais, Amethi at its discretion may extend the deadline for the submission of bids if it thinks necessary to do so or if the bid document undergoes changes during the bidding period, in order to give prospective bidders time to take into consideration the amendments while preparing their bids.

### 4. Preparation of Bids

The Technical and Financial bids must be submitted in two separate sealed envelopes super scribed as Technical and Financial bid on the envelops and these two envelopes must be kept under one sealed envelope. Bidder should avoid, as far as possible, corrections, overwriting, erasures or postscripts in the bid documents. In case however, any corrections, overwriting, erasures or postscripts have to be made in the bids, they should be supported by dated signatures of the same authorized person signing the bid documents. However, bidder shall not be entitled to amend/ add/ delete/ correct the clauses mentioned in the entire tender document. The technical bid must contain all supporting documents mentioned in the eligibility criteria and filled and duly signed Annexure-I and Annexure-II. The financial bid must contain the Annexure-III and Annexure-IV duly filled and signed and put in separate envelop super scribed Financial Bid.

#### 5. Forfeiture of EMD:

- i. In case of the bidder whose offer is accepted, the EMD will be returned on submission of Performance Security.
- ii. The successful bidder, on award of contract/ order, must send the contract/ order acceptance in writing, within 07 days of award of contract/ order, failing which the EMD will be forfeited and the order will be cancelled.
- iii. If the bidder withdraws the bid during the period of bid validity specified in thetender.

#### 6. Period of validity of bids:

- i. Bids shall be valid for minimum 180 days from the date of submission. A bid valid for a shorter period shall stand rejected.
- ii. RGIPT, Jais, Amethi may ask for the bidder's consent to extend the period of validity. Such request and the response shall be made in writing only. The bidder is free not to accept such request without forfeiting the EMD. A bidder agreeing to the request for extension will not be permitted to modify his bid.
- **7.** Payment terms: 100% payment will be released against successful supply of vehicles at site i.e Rajiv Gandhi Institute of Petroleum Technology, Jais, Amethi and submission of original tax Bill/ Invoice, Insurance and registration, certified by the purchase committee.
- 8. Replacements of Goods Broken, Damaged or Short: If whole or part of the goods/ equipment supplied against the order is found defective/non-functional or without specification the supplier will have to replace the defective goods/equipment to make equipment operational within a reasonable time (not exceeding two months from the date of intimation to the supplier or the Indian Agent), failure to which the supplier will have to refund the full cost of the equipment including freight, Insurance etc.

<u>**Iurisdiction:**</u> The disputes, legal matters, court matters, if any shall be subject to Raebareli/ Amethi jurisdiction only.

9. **L.D Clause**: In case of any delay in supply of the vehicle, liquidate damage at the rate of 0.5% of the order value per day of delay, subject to maximum of 5% will be deducted from the final bill.

#### 10. Deadline for Submission of Bids:

- i. The Bid documents shall be neatly arranged. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the Bid. The conditional bid will be summarily rejected.
- ii. Bids must be received by RGIPT, Jais, Amethi before the due date and time at the address specified in the tender document.
- iii. RGIPT, Jais, Amethi may extend this deadline for submission of bids by amending the bid documents and the same shall be suitably notified on its website.
- iv. RGIPT, Jais, Amethi shall not be responsible and liable for the

#### 11. Purchase Order:
