
→ In addition, all students will pay mess advance of ₹ 25,000.00 per semester at the beginning of each semester, which will be adjusted towards actual bills at the end of each academic year.

→ Any stay, other than the semester studies would be charged @ ₹ 100.00 for each day of stay at the Institutes Hostel. Mess facility might be available on per day payment basis.

Note: a) Hostel accommodation and mess facilities will be provided only after the full payment of semester fees, mess advance and clearance of dues.

b) Physical registration will not be permitted unless all dues are cleared. Students failing to do so will be treated as non-registered.

c) A non-registered student shall not be allowed to attend classes and will be marked absent during the period of non-registration. No relaxation in attendance requirements shall be granted for duration of non-registration.
