Eligibility Criteria for Bidders

1. **EMD:** Earnest Money Deposit as specified in NIT to be furnished in any of the following forms and shall be valid for up to 120 days:

The scanned image of the earnest money deposit receipt is to be uploaded online along with the technical bid. The EMD can be deposited in the below-mentioned Institute's Bank Account through NEFT/Demand Draft issued by any Nationalized Bank in favour of "Rajiv Gandhi Institute of Petroleum Technology, payable at Jais" and share the UTR / Transaction number and date of Transaction in the Technical bid and the copy of transaction receipt must be uploaded online on the CPP portal along with the other NIT documents.

- 2. Bidders shall be a Sole Proprietor/ Partnership Firm /Company governed by rules regulations and other applicable laws in India.
- 3. Bidder must have GST registration certificate issued by the competent authority.
- 4. Bidder must have PAN issued by the competent authority.
- 5. The EMD for the bid is Rs 1,75,000/- (Rupees One Lakh Seventy-Five Thousand Only). MSME exemption is allowed. Bidders registered under MSME with valid certification shall be exempted from submission of EMD. This exemption is limited to EMD only and shall not apply to any other eligibility conditions.
- 6. Bidders should have experience of successfully completing/ executing CIVIL construction including electrical works or Repair and Maintenance work in Central or state Government/public sector undertakings/autonomous bodies during last Five years ending on 31.03.2025 as per following: -
 - (a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost i.e 28 Lakhs.

or

(b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost i.e. 35 Lakhs.

or

(c) One similar completed works costing not less than the amount equal to 80% of the estimated cost i.e. 56 Lakhs.

Work completion certificates along with work order shall be submitted for similar work (CIVIL construction including electrical works or Repair and Maintenance work) experience.

7. Annual Income Tax Return of last three financial year (2022-23, 2023-24 and 2024-2025) should be submitted.

- 8. The bidder should not be blacklisted by any office/ department of Central/ State Government/ Public Undertaking. A Certificate/Undertaking on the letter head of the Company to the effect that the bidder has not been blacklisted anywhere in India by any organization is to b submitted. A self- certification to this effect is required to be enclosed as per **Annexure -8.**
- 9. The contractor should submit the copy of "Site Visit Report/Survey Letter" issued by the RGIPT, Jais, Amethi Campus in respect of work site visit made by the contractor before the participation in the tender.
- 10. The contractor should have valid registration with all Statutory Authorities such as Registrar of firms, Central/State Labour Department (with valid license), ESI, PF, GST, PAN etc.
- 11. Annual average turnover of the contractor during the last 3 years ending March 31, 2025, should be at least Rs.21.0 Lakhs. A CA Certified document and profit and loss account of the respective financial year should be submitted by the bidder along with his technical bid.

(All above valid documents need to be submitted to get qualified technically. The bid of a contractor who fails to submit any of the valid documents as per above eligibility criteria, will be summarily rejected without assigning any reason.)

Note:

- (1) The meaning of "Similar Work" for purpose of tender has been defined as "Experience in "CIVIL construction including electrical works or Repair and Maintenance work".
- (2) The details furnished shall be for the maintenance jobs. The contractor must have experience in operation & maintenance of Civil and Electrical Work.
 - The vendors submitting the credential of installation works shall not be eligible for prequalification.
- (3) The track record of the contractor should be clean, and he should not have any involvement in any illegal activities or frauds.
- (4) The contractor must submit duly filled forms/annexure as required in the tender document.

INSTRUCTIONS TO BIDDERS

- 1. The Bidders must understand that this annual maintenance Rate contract is for repair, maintenance, and sometimes new works. Separate work orders will be given after obtaining Approval of the Competent Authority for respective works. The Quantum and amount of every work order can vary as per requirement of the work and the bidders should have financial capacity to execute the work on its own. Since the work will be generated on a requirement basis it can happen that at times there is no work and at times there is excessive work. The contractor will have to mobilize the site as per the work requirement and will have to complete the work within the period mentioned in the respective work order. Any work being executed by the contractor (may be any small or big) has to be executed as per laid down S.O.P, Specifications, quality norms, and workmanship within the time prescribed. No claim regarding a very small quantum of work, excess work, non- availability of manpower, etc. will be entertained. Bidders are also advised to thoroughly read the tender document and Tender conditions, visit the site and understand the type of work before bidding to avoid any confusion.
- 2. RGIPT, Jais, Amethi shall not be bound to accept the lowest tender and reserves the right to reject any or all the Tenders without assigning any reason.
- 3. Tender Documents shall be duly filled, signed & stamped, and uploaded within the last date of submission as mentioned in the tender notice. Late tenders and conditional tenders shall not be considered. The last date for receipt of the Tender will not be extended under any circumstances on the request of the bidder unless otherwise the date is declared a holiday for RGIPT Jais Amethi Campus, in which case the next working day will be treated as the last date of receipt of the Tender document. However the competent authority, RGIPT, Jais, Amethi may extend the last date of tender.
- If by mistake any conditional tender gets accepted or work gets awarded and later that condition is/ are recognized or is/ are shown or emphasized by the contractor to be implemented, then his awarded work can be canceled by the Institute. The Contractor will have no claim in this regard.
- 4. Financial bids must be filled and submitted in the prescribed formats given on the CPP portal separately. A sample format of the financial bid has been attached with the technical bid just for the understanding of the bidders. This is required to be kept blank and just signed and stamped along with the other documents of this Tender. If financial bid is found along with the technical bid of this Tender, then the Tender shall be straight away rejected.
- 5. The bid must be valid for a minimum period of 120 days from the date of opening. If the bidder modifies his tender or revokes the same during this period, the tender may, at the discretion of RGIPT Authorities, be treated as canceled, and the earnest money will be forfeited.

6. Percentage Rate Contract:

This being a percentage rate contract, the rate quoted shall remain constant and errors if any in the extension/total shall be subject to corrections. The Estimated quantities/ Amount of Work involved stipulated above/ in the price bid are approximate and hence any increase/reduction thereof during the currency of the contract shall not vitiate the contract. The approximate estimated value of this work is indicated in NIT. This estimate however is not guaranteed and is merely given as a rough guide, and if the work costs more or less, bidder will have no claim on that account.

- The bidder should quote percentage below on the total amount of tender in percentage rate tender. If the bidder does not quote any percentage below on the total amount of tender, the tender shall be treated as invalid and will not be considered as the lowest tender.
- In case any bidder encloses the price (financial) bid within technical bid, the same shall be rejected summarily.
- In case the lowest tendered amount (estimated cost + amount worked on the basis of percentage below) of two or more contractors is same, such lowest contractors will be asked to submit sealed revised offer in the form of letter mentioning percentage above/ below on estimated cost of tender including all sub sections/sub heads as the case may be, but the revised percentage quoted below on tendered cost or on each sub section/ sub head should not be higher than the percentage quoted at the time of submission of tender.
- The lowest tender shall be decided on the basis of revised offers. In case any such contractor refuses to submit a revised offer, then it shall be treated as withdrawal of his tender before acceptance and 50% of earnest money shall be forfeited. If the revised tendered amount of two more contractors received in revised offer is again found to be equal, the lowest tender, among such contractors, shall be decided by draw of lots in the presence of Chairman, Council of Wardens, the lowest contractors those have quoted equal amount of their tenders. In case all the lowest contractors those have quoted the same tendered amount, refuse to submit revised offers, then tenders are to be recalled after forfeiting 50% of EMD of each contractor. Contractor(s), whose earnest money is forfeited because of non-submission of revised offer, shall not be allowed to participate in the re-tendering process of the work.
- 7. In case there is variation occurs in GST rates as per Govt. of India i.e., if GST variation in rate is above 18% then an additional percentage above 18% (Applicable rate 18%) shall be paid by the Institute and if GST variation in rate is reduced from 18% then the percentage difference below 18 % (18 % Applicable Rate) will be recovered from the contractor.
- 8. If any misprint discrepancy/misprint is Noticed in the specification or BOQ or rates or unit, it should be clarified by the Institute before quoting the rate.

If any discrepancy between the price bid format of this Tender document and macros enabled Excel file of the actual price bid on the CPP portal is observed by the Bidder or if any item unit/ rates are found impractical then in that case the same has to be brought to the notice of the Institute before the last date of submission. If any such discrepancy is brought to the notice of the Institute the required correction/ corrigendum can be made. If such an issue is found at a later stage after the award of the work either by the Contractor or by the Institute, then the logical decision based on the standard practice and as per the Institute's internal documentation shall be taken by the Institute and the same decision will be binding to the contractor and no claim whatsoever will be entertained in this regard.

- 9. The following procedures shall be adopted in case of difference in quoted rates in figures and words and extensions:
 - **a.** Where there is a difference between rates in figures and numbers, the rates quoted in words shall be considered as correct.
 - **b.** Where the amount of an item is not worked out or it does not correspond to the rate either in figure or in words, the rates quoted in words shall be considered as a correct and necessary extension made.
 - **c.** Where the rate quoted by the tenderer in figures and words tally, but the amount is not worked out

correctly, the rates quoted by the tenderer shall be considered as correct and the amount shall be corrected accordingly.

- 10. RGIPT, Jais Amethi Campus does not bind themselves to accept the lowest or any other tender and reserves the right to accept or reject any or all the tenders either in full or in part without assigning any reason.
- 11. The tender shall be opened & evaluated by the tender committee and the successful tenderer shall be informed.
- 12. If any of the documents submitted by the tenderer is found fake, incorrect at any stage, even after the acceptance of tender and work being initiated OR completed, the contract will be terminated for which the concerned tenderer will itself be responsible and no compensation, etc., will be paid by the RGIPT, Jais Amethi Campus.
- 13. 5% of the payable bill value of each work will be retained from each bill as a security till completion of defect liability period & shall be released after completion of the Defect Liability Period. The Defect liability period shall be separately mentioned in each work order issued by the Engineer In charge of the respective works. In general, the Defect liability period is 6 months from the date of completion of the respective work awarded through the respective work order. No interest shall be paid on the amount retained. The Retention money/ Security Deposit deducted above for different works awarded through separate work orders shall be refunded to the contractor after the completion of the stipulated Defect liability period of the respective work order.
- 14. The tenderer shall not be at liberty to withdraw or modify his tender or any terms and conditions thereof before the expiry of said period. Tenderers are expected to clarify only such points as asked for specifically by the Accepting Officer in writing. Any withdrawal or modification made within the said period constitutes a breach of contract and the tenderer shall be liable to pay damages to the Institute in consequence thereof. Apart from the above the EMD deposited by the Bidder may be forfeited.
- 15. Any tender that proposes any alterations to any of the conditions laid down or proposes any other conditions of any description whatsoever is liable to be rejected.
- 16. The EMD shall not carry interest and will be refunded to the tenderers if the tender is not accepted unless the same is forfeited to the Institute for any breach on its part. If his tender is accepted, the Earnest Money will be converted into a Performance Security Deposit as stipulated, subject to the approval of the competent authority of RGIPT.
- 17. The drawing (if any) should be returned along with the tender documents duly signed.
- 18. The submission of a tender by a tenderer implies that he has read all the terms and conditions of the contract and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors bearing on the execution of the work.
- 19. The agencies whose contracts were terminated/ are in litigation with RGIPT, Jais Amethi Campus or are debarred on account of nonperformance in RGIPT, Jais Amethi Campus work or have any criminal case in any police station/ court of India or are not performing and deliberately delaying the work awarded to them by RGIPT or by any other institution as the case may be, will not be eligible for bidding this tender.
- 20. Since this is an electronic mode of tendering, any manual or mechanical errors committed before uploading or during the process of uploading the document shall be duly accepted by the Tenderers. The Tenderers shall not have a claim whatsoever in this regard.
- 21. The Tenderers shall download and sign the **LETTER OF UNDERTAKING (Annexure-2)** of the document and upload the same along with other documents.

- 22. Tenders of those Tenderers who fulfill the criteria mentioned above will only be considered for opening of Price Bid. Tenders received without earnest money those which are incomplete invalid or conditional will be rejected and no correspondence will be entertained in case of rejection.
- 23. Contractors/agencies are subject to be disqualified, even though they meet the qualifying criteria if they make misleading or false representations in the request, statements, and attachments submitted in proof of qualification requirements including withholding information and or have a record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures, requesting for claims not admissible under the contract conditions, etc.
- 24. The Institute reserves the right to accept any tender either in full or in part, to reject all the tenders or distribute the work in more than one agency without assigning any reason. The decision of the Institute in this regard shall be final and binding to the Bidder. The bidder/ bidders in such case cannot claim any compensation for change in the scope / Qty. of work.
- 25. This instruction shall be deemed to form an integral part of the contract to be entered for this work. The Institute shall have right to add any condition at the time of Contract or issuance of work order.
- 26. **GST/ Taxes**: GST or any other tax applicable in respect of inputs procured by the contractor for this contract shall be payable by the Contractor and the Institute will not entertain any claim whatsoever in respect of the same otherwise expressly mentioned in the tender conditions. The rates shall be inclusive of GST as applicable.
- 27. Where the tender schedule contains specialized items of work, it will be entirely at the discretion of the Institute to delete these items from the Price Bid and allot these items of work to other Contractors specialized in these works. In such cases, the main Contractor will have to render all necessary co-operation to the other agencies involved to ensure smooth progress of all work.
- 28. The Contractor's responsibility for this contract shall commence from the date of commencement mentioned in the work order which will be issued by the Engineer-in-Charge after acceptance of work.
- 29. If the tenderer deliberately gives wrong information in his tender or creates conditions favorable for acceptance of his tender, the Accepting Officer reserves the right to reject such tender at any stage, forfeit the EMD, and take Administrative Action against the tenderer like non-issue of tenders, etc., as deemed fit by the Accepting Officer.
- 30. At any time, even after the award of the contract also, if it is found that the tenderers have deliberately given wrong information or false credentials at the time of tender or at any other time in connection with the contract, RGIPT, Jais Amethi Campus reserves the right to reject the offer or cancel the contract. In such case, the contractor/tenderer is liable to forefeet the EMD amount including any other action as deemed fit. The contractor/tenderer is also liable to be permanently debarred for participating in any tender process of RGIPT, Jais Amethi campus concerning any type of work in the future.

31. PRECEDENCE FOR ACCEPTANCE:

If any contradiction/variance is observed in different components of the tender, the following precedence shall be observed:

- i) Tender Notice and Instructions to Tenderers shall have precedence over Special Conditions.
- ii) Special Conditions shall have precedence over General Conditions of Contract.
- ii) The successful bidder will be required to submit the signed hard copy of the same after issuing of LOI to him before the start of work.

32. The tenderer shall not increase their quoted rates in case the Accepting Officer negotiates for the reduction in rates, such negotiations shall not amount to cancellation or withdrawal of the original offer and the rates originally quoted shall be binding on the tenderer.

33. Rate quoted to include:

- a) Working hours as per office timings
- b) Movement of men, material, and stacking all as directed by the Engineer-in-Charge.
- c) Removing surplus materials and stacking all as directed by the Engineer-in-Charge.
- 34. Before tendering the tenderers are advised to inspect the site of work, and its environments and be well acquainted with the actual working, restrictions in the campus area, security procedures for entry of men and materials, prevalent conditions, the position of materials and labor, General and Special Conditions of contract, Instructions to Tenderers, drawing (if any) and Specifications and all other documents which form part of the agreement to be enlisted into.
- 35. In the event of a tender being submitted by a Partnership Firm the tender must be signed separately and legibly by each partner member of the Firm or in their absence a person holding the power of attorney on behalf of the Firm concerned. In the latter case, a copy of the power of attorney.
- 36. The successful tenderer shall submit Initial Performance security of 5% of Contract Value. The EMD submitted in this case will also be converted to performance security 5 % of the contract value has to be submitted as performance security in the form of DD/FDR/Bank Guarantee in favor of the Rajiv Gandhi Institute Petroleum Technology, Jais Amethi Campus within 10 days of award of work.

An Agreement on Rs 100 stamp paper will be required to be executed within 10 days of the issue of LOI and if the contractor fails to get the agreement done within 10 days unless otherwise any extension had been granted by RGIPT Jais campus then the Work awarded/ LOI issued will be straightaway considered as Terminated.

- 1. The AMC shall be initially for a period of one year and may be extended by the Competent Authority up to two more years on observation of satisfactory performance with the same technical & financial terms and conditions. However, no extension can be claimed as a matter of right by the bidder.
- 2. The contract is for providing maintenance services or for any New Construction/ modifications as per the requirement and **not for** supply of Contract Labour. The workers employed by the contractor for providing the services shall be of his/their employees and not of the RGIPT Jais Amethi.
- 3. The contractor, whose tender is accepted, shall deposit an amount equal to 5 % of the contract value towards Security Deposit for the due performance of the contract. The deposit shall be drawn in favour of "Rajiv Gandhi Institute of Petroleum Technology" as interest free security deposit in the form of FDR from any of the Commercial Banks (or) Bank Guarantee from any of the Commercial Banks (or) Fixed Deposit Receipt (FDR) (or) Insurance Surety Bonds.
- 4. The contractor shall provide the maintenance services as given in 'Scope of Work' to the satisfaction of the RGIPT Jais Amethi. The contractor shall maintain the good workmanship at all the time during the currency of the contract or even during the extended period of contract. The performance of the contractor shall be reviewed monthly and the during the monthly review if any dissatisfaction is reported the contractors shall immediately correct the same and if the defect as notified during monthly review continues, the same shall be treated as breach of contract leading to termination of the contract.
- 5. The Contractor shall be liable to timely completion of work awarded to the contractor in work orders issued from time to time. Any delay in completion of work will be treated to be the breach of contract. If the contractor fails to execute the maintenance works as detailed in Scope of Work or Work Order within stipulated time, the RGIPT Jais Amethi will be at liberty to execute the works through an alternate source and the charges incurred shall be recovered from the contractor.
- 6. The contractor shall provide all Civil and Electrical Operation and Maintenance tools at RGIPT Jais Campus on its own expenses.
- 7. The contractor shall be bound to remove the defect noticed in any work done during the defect liability period as stipulated in the defect liability clause of the work order. However, if the contractors fails to do the same the RGIPT shall be entitled to get the defect removed from its sources/other agency and the cost shall be recovered from the Contractor.
- 8. The contractor shall permit the RGIPT Jais Amethi to hold or deduct the amount from the bill for non-performance or part performance or failure to discharge obligations under this contract.
- 9. The contractor shall comply with the provisions of all Labour Laws, which are applicable to 'the Contractor' or his employees and shall be solely responsible for liabilities arising out of such compliance, non-compliance or implementation or non-implementation. The contractor will furnish proof of compliance of all Labour Laws requirements including obtaining licenses, filing of monthly/quarterly/annual returns as the case may be and any other statutory requirement and furnish calculations and proof of payments made to all Government/Statutory Authorities under EPF, ESIC, Labour Welfare Fund Act, Payment of Bonus Act, etc. within time limit allowed under the respective Acts and all other statutory rules as amended from time to time.

- Submission of proof with regard to the compliance of the aforesaid conditions will be a pre-condition for processing the bills of the contractor for payment.
- 10. The contractor shall be responsible for maintenance of proper records as required under the provisions of various Labour Laws / Statutory Acts applicable to the contractor and contract employees such as attendance register, overtime register, advance register, register of deductions for damage & loss, register of fines, accident register etc. and produce them for inspection as and when demanded by RGIPT Jais Amethi or any appropriate Labour authorities.
- 11. The contractor shall not subcontract the works unless permitted specifically by the RGIPT Jais Amethi in writing. Any subletting shall be treated as breach of contract and may lead to termination of contract.
- 12. The contractor shall be responsible for all acts done by the personnel engaged by him and for maintenance of proper discipline by his personnel at the premises of the RGIPT Jais Amethi. Any act of indiscipline/misconduct/theft/pilferage on the part of any personnel engaged by the contractor resulting any loss to the RGIPT Jais Amethi in kind or cash will be viewed seriously and the RGIPT Jais Amethi shall have the right to levy damages or fine from the contractor and even terminate the contract forthwith along with black listing of the contractor. Imposition of any penalty/damages will not affect the right of RGIPT to initiate/report the act to criminal law enforcement agencies.
- 13. RGIPT will have right to require the contractor to remove or replace any of the personnel employed/deployed/engaged by the contractor with regard to execution of work of present contract and the Contractor shall be bound to remove or replace the said personnel. Violation of the present condition shall be considered as breach of contract.
- 14. In the event, any damage is caused to the movable or immovable property of the RGIPT Jais Amethi or to the property of employees of the RGIPT Jais Amethi, the RGIPT Jais Amethi reserves the right to compute the damage in terms of money and to deduct the money from the bill of the contractor or from the amount payable to the contractor by the RGIPT Jais Amethi and the remaining amount, if any, by the way of civil damages.
- 15. The contractor shall submit the bills in the first week of every month along with a monthly report for the works carried out in the previous month and the proof of statutory compliances. The RGIPT Jais Amethi shall pay AMC charges on monthly basis within 7 days of submission of bills by the contractor along with all requsit documents and certified by the concerned employee/official to the effect that the maintenance works have been carried out as per the contract. Applicable TDS will be deducted while making the payment.
- 16. GST, if any, as per applicable rates, shall be reimbursed by the RGIPT Jais Amethi on submission of proof of payment along with monthly bill.
- 17. RGIPT Jais Amethi shall not be responsible for any accident/injury or loss of life of any of the persons engaged by the contractor that may take place while executing the contract. Any compensation or expenditure towards the treatment of such injury or loss of life shall be sole responsibility of the contractor. At his cost, the contractor shall obtain appropriate/adequate insurance policy to his personnel towards meeting the liability of compensation arising out of death, injury, disablement, etc. at work.

- 18. RGIPT may at its discretion reduce or increase the quantum of work and the contractors shall be bound to execute the same on the same rates on which the contract has been awarded to the contractor.
- 19. Breach of contract by the contractor shall not be limited to the express breach of contract mentioned in the General Condition of Contract.
- 20. The contractor will have no right to terminate the contract prior to one year. However, RGIPT may terminate the contract on following conditions:
 - i. If the contractor failes to perform any obligation under the contract.
 - ii. Upon breach of any of the terms and conditions of the contract.
 - iii. In case the contractors failes to remove any defect notified by the RGIPT with 7 days of its notification to the contractor.
 - iv. Contractor being unable to execute the work. If the contractor leaves the site unattended for a period of more that 15 days it shall be deemed that the contractor is unable to execute the work and has abandoned the work.
 - v. If the contractor is declared as insolvent and otherwise become or declared incapable of performing its function under law.
 - RGIPT may terminate the contract, without assigning any reason upon service of a written notice of one month.

In case the complete Annual Maintenance contract is terminated then:

- a. Available performance security will be forfeited.
- b. Available Retention money and Payment for any unbilled completed work/ payable amount for the items of respective work which are completed but not billed will be withheld by the Institute for recovering the penalty/ risk and cost of any incomplete work/liabilities of the contractor. Any payable amount from these bills and retention money that remains after the adjustment of risk and cost of the Agreement value balance/ penalty/ any other liabilities of the contractor will only be paid to him after the submission of no claim certificate by the contractor.
- 21. All the obligation of the parties under the contract prior to termination of contract, including the defect liability clause, shall remain intact upon termination of contract.
- 22. The Termination of contract will not affect the rights of RGIPT to take any other action against the contractor including blacklisting of Contractor.
- 23. The contractor shall execute the agreement related to this contract on Rs.100/- stamp paper as per proforma prescribed by the RGIPT Jais Amethi.
- 24. In case any loss is caused to RGIPT due to any action or inaction of the contractor or the RGIPT is required to may any payment for which the contractor is liable under the contract or law, the contractor shall indemnify the RGIPT and shall keep indemnifying.

- 25. All terms and conditions mentioned in the tender document, General Condition of Contract, Special Condition of Contract and Work Order shall be deemed to be the part of Contract between the parties.
- 26. In case of any dispute the matter shall be referred to the Director RGIPT who shall nominate a person for Mediation between the parties. However, if the parties fails to settle the dispute through mediation within two months the matter shall be referred to the sole Arbitrator and the provisions of The Arbitration and Conciliation Act, 1996 as amended from time to time shall be applicable.
- 27. The contract shall be government by law made by the Parliament of India and for the subjects on which the State Law is applicable shall be government by the laws made by State Legislature of Uttar Pradesh
- 28. Any dispute amongst the parties shall be subject to the jurisdiction of the Court exercising territorial jurisdiction over Amethi District.

Special Condition of Contract

- NAME OF WORK: Annual Maintenance Contract for CIVIL (Carpentry, Aluminum, False Ceiling, Painting, Masonry, Plumbing and Sanitary) And Electrical (Electrical and DG Sets) WORK at RGIPT, Jais Amethi UP 229304.
- 2. **OWNER:** Rajiv Gandhi Institute of Petroleum Technology, Jais Amethi.

3. ENGINEER/ENGINEER-IN-CHARGE:

Assistant Engineer (Civil), Hostel Office, RGIPT, Jais Amethi Campus or any person designated from time to time by Head Administration and shall include those who are expressly authorized by him to act for and on his behalf for operation of this contract.

4. SCOPE OF WORK:

AMC means Comprehensive Annual Maintenance Contract with material & labour. The scope of work under this contract shall include the work of Addition and Alteration, repair, and maintenance, replace, renovate, modify the existing set-up etc. as instructed by the Employer through work orders/job orders etc.

- The quantities indicated are approximate and may vary at the time of execution. RGIPT will exercise absolute discretion for operating all or some items of the schedule. The Contractor shall provide all necessary consumable materials, equipment, labour etc. for the execution and maintenance of the work till completion unless otherwise mentioned in this tender document. All materials required for the work shall be as per technical specifications and approved by Engineer-in-Charge prior to procurement and use.
- Under this Annual Maintenance Contract (AMC) the contractor has to be supply of various type of Civil
 and Electrical materials as mentioned in the Bill of Quantity (BOQ) and for new construction/
 addition/alteration/modifications as per DSR-2023 as per instruction of Engineer-in-Charge.
- All Tools & tackles, plants, machineries, equipment's, and materials required to carry out the Civil and Electrical maintenance /new works at the site shall be provided by the Agency at his own cost.
- Agency will maintain Manpower Muster Roll & Wage Register as per law in case of New Construction works.
- The Type of material to be used has been specified in the BOQ. Different works shall be awarded through respective work orders along with the BOQ containing the required items of the price bid and their quantities after prior Approval of the competent Authority. The contractor shall be required to strictly adhere to the Quality control, CPWD Specification for CIVIL AND ELECTRICAL WORKS and complete the work up to the satisfaction of User department/ Engineer in charge (as the case may be). Mainly there following type of works ie.:

A) Civil Maintenance & Allied Works:

a) Repair and maintenance of Aluminum, False Ceiling, welding and Carpentry issues such as replacement/ repairing of damaged wooden door frame (Chowkhat), Shutter, MS Bed, MS Table, MS Chair, aluminum windows, doors, ventilators, partitions cutting and installation of curtain rod, brackets and curtain etc. of rooms and common area of hostel.

- b) Repairing of MS doors, gate rolling shutters, MS grills by cutting and removing the damaged portions, replacing with suitable MS sections for frames, shutters, attending to necessary repairs and adjustments for easy operation of shutters using necessary commodities similar to the existing one for filling up the holes, if any, in the frames. Replacement of MS sections, members will be paid extra as well as for the arrangement of welding machines & welders.
- c) Rectifying and replacing hooks, hinges, aldrops, tower bolts, knobs, handles, door locks, door closers, door stoppers, floor springs, hold fasts, bearing, clamps, picture hooks, nails, screws, nylon rope and brackets for cloth drying arrangement etc., with suitable material like the existing one Leveling of doors and window surfaces to ensure proper functioning of doors, windows ventilators etc.
- d) Repairing/Painting cracks in walls and ceilings of Hostel rooms and common area.
- e) Painting of playgrounds walls, MS grill railing, staircase raling of hostel rooms and common area.
- f) Painting of Hostel rooms and common area in semester end/gap.
- g) Repairing damaged plaster surface of hostel rooms, corridor area, surrounding area of hostel building and other area.
- h) Repairing or replacing broken tiles (floor/wall), repairing of toilet core cutting leakage points.
- The scope of services will also include periodical cleaning and clearing of existing water supply lines, sewerage disposal system (including underground Sewerage Pipes and Inspection chambers within the campus of hostel area) from time to time or as and when considered necessary.
- j) The contractor will be responsible to arrange for all types of tools (Civil and Electrical work) required for the purpose at their cost.
- k) The necessary materials viz. Plumbing Pipes and fittings, Spindle, CP fittings, Stone Ware Pipes, CI/PVC Drainage Pipes with fittings of approved quality required for day-to-day maintenance / repairs / replacement will be arranged by the contractor.
- The contractor will ensure upkeep of various fittings and fixtures to ensure the same in perfect working
 conditions and material used for repair should be of matching standard. In case of contractor's failure
 in doing so, the RGIPT will be at liberty to recover the cost of such costly Fittings from the contractor or
 will get the same replaced at their risk and cost.
- m) It shall be responsibility of the contractor to execute the work of maintenance and repairs including replacement of sanitary and plumbing fittings at all levels and heights of the buildings for which necessary Safety belt, Scaffolding, Helmets etc. will be arranged by the Contractor at their cost.
- n) Dismantling and replacing the Sanitary wares, fittings etc. Water proofing plaster and other water proofing works to arrest the seepage in toilets.
- Dismantling and replacement of Kitchen platform, sink, floor tiles, wall tiles, Brickwork, Dismantling and replacement of other type of flooring, Brick coba work, Dismantling and redoing Brickwork, R.C.C. works etc.
- p) Replacement of the Glasses, mirrors, Door closer etc.
- q) Repair of Wooden/Aluminum, FRP, CPVC door, windows, Amirah etc.
- r) Complete new construction can also be given such as construction of Brick wall, Drains, Trusses, M.S. Structures, Room, flooring etc. depending on the requirement of the institute. This type of work may also include few Interiors, false ceiling, false walls etc.

- s) The contractor is required to keep strong Quality control and get the work which shall be hidden inspected, measured, and photographed by the concerned Engineer/ officer before covering it up.
- t) Any other works as and when directed by the authorized person from RGIPT other than mentioned above falling under the domain of Civil work of hostel area.

B) Electrical Maintenance & Allied Works:

- a) Electrical work of hostel area as material required for maintenance of the various electrical nature of complaints.
- b) Replacement of defective MCB, defective lights, defective geysers parts, repairing of exhaust fans, replacement of damaged switch, sockets and plug top, repairing of ceiling fans, wall fans, air coolers, water coolers, repairing of 4 X 5.5TR and 3 X 8.5TR Ductable AC Units (Carrier make), repairing of Submersible pump and starter, replacement of solenoid valves etc.
- c) Operation and maintenance of water supply pumps of hostel area.
- d) Operation and maintenance of DG Sets of the hostel area, cost of diesel consumption on actuals and Transportation will be borne by RGIPT, Jais Campus.
- e) Any other works as and when directed by the authorized person from RGIPT other than mentioned above falling under the domain of Electrical work of hostel area.
- C) Logbook and complaint books, all stationery like registers, sheets, markers, pens and pencils etc. will be supplied by the contractor and no extra payment for these shall be made.
- D) The Contractor shall maintain/stock sufficient quantity of materials and spares as per (BOQ) at site to meet the requirement of attending the complaints as per direction of the Engineer-In-Charge.
- E) The supply shall be made at RGIPT Hostel Maintenance Store or any other location under the jurisdiction of RGIPT, Jais, Amethi.

5. CONTRACT RATES:

The contract rates are for work to be done in RGIPT, Jais, Amethi Campus and shall be firm throughout the currency of the contract including the extended period, if any, and shall not be subjected to any escalation due to any reason whatsoever it may be.

No escalation claim shall be entertained for any statutory increase by the Local Authorties, State/Central Government during the contract period. The quantities mentioned in the financial bid are tentative. The rates quoted in the tender and as accepted by the RGIPT with or without modification shall hold good for any increase/decrease in quantities. Any of the items may be deleted as per directions of RGIPT, Jais, Amethi Campus.

6. LEVY/TAXES PAYABLE BY CONTRACTOR:

Building and other Construction Workers Welfare CESS or any other tax, levy, or CESS in respect of input for or output by this contract shall be payable by the contractor and RGIPT shall not entertain any claim whatsoever in this respect. The contractor shall deposit royalty and obtain the necessary permit for the supply of the red bare, stone, Paint Material, etc. from local authorities (If Applicable as per the

Applicable law of land). If pursuant to or under any law, notification, or order any royalty, cess or the like becomes payable by the Institute and does not at any time become payable by the contractor to the State Government or local authorities in respect of any material used by the contractor in the works, then in such a case, it shall be lawful to RGIPT, Jais, Amethi and it will have the right and be entitled to recover the amount paid in the circumstances as aforesaid from dues of the contractor.

Conditions for reimbursement/ recovery of levy/taxes if levied after receipt of Tenders.

All tendered rates shall be inclusive of any tax, levy, or cess applicable on the last stipulated date of receipt of tender including extension if any. No adjustment i.e., increase or decrease shall be made for any variation in the rate of, the Building and Other Construction Workers Welfare Cess or any tax, levy, or cess applicable on inputs.

However, the effect of variation in rates of GST or Building and Other Construction Workers Welfare Cess or imposition or repeal of any other tax, levy, or cess applicable on the output of the works contract shall be adjusted on either side, increase or decrease.

Provided further that for Building and Other Construction Workers Welfare Cess or any tax (other than GST), levy or cess varied or imposed after the last date of receipt of tender including extension if any, any increase shall be reimbursed to the contractor only if the contractor necessarily and properly pays such increased amount of taxes/levies/cess. Provided further that such increase including GST shall not be made in the extended period of contract for which the contractor alone is responsible for delay as determined by authority for extension of time.

All rates shall be inclusive of GST.

- (i) The contractor shall keep necessary books of accounts and other documents for the purpose of this condition as may be necessary and shall allow inspection of the same by a duly authorized representative of the Government and/or the Engineer-in-Charge and shall also furnish such other information/document as the Engineer-in-Charge may require from time to time.
- (ii) The contractor shall, within a period of 30 days of the imposition of any further tax or levy or cess, or variation or repeal of tax or levy or cess/ reduction of such taxes/ cess, etc. shall give a written notice thereof to the Engineer-in-charge that the same is given pursuant to this condition, together with all necessary information relating thereto. Decision of the Director of the Institute in this regard to either compensate/ recover the changes in the rates of taxes/ levy of cess etc. as the case may be shall be final and binding to the Contractor.

7. ESI & PF CODE:

The contractors are required to comply with the provisions of the ESI & PF Act as per applicability. The contractor shall be required to indemnify RGIPT, Jais Amethi Campus for any liabilities arising on account of the ESI & PF Act.

8. The records/registers that the Engineer-in-Charge considers necessary for monitoring the works & inspection by the Chairman, Council of Wardens are to be maintained at the site in co-ordination with Engineer- in- Charge and Agency.

9. **COMMENCEMENT DATE:**

The date of commencement of work shall be the date of issue of the Letter of Intent. The contractor shall have to submit Performance Guarantee as stipulated above within 10 days from the date of issue of Letter of Intent failing which the E.M.D. may be forfeited. Work orders for the works awarded during the AMC period shall be issued for separate works with the completion date /period stipulated. The contractor is required to start the work within 3 days of the issue date of the work/purchase order and the work shall be completed within the stipulated time frame. Any work not completed by the contractor/ executed in inferior quality/unnecessarily held up/ disrupted because of any irregularity whatsoever, Engineer In charge/ Competent authority of RGIPT, Jais, Amethi Campus upon serving a 10 days' notice shall get work done by other agency at the risk and cost of contractor and the Contractor will have no claim for compensation in this regard. The scope of work may be increased on similar other buildings, subject to the performance of awarded work. The contractor will maintain a work force for 'New Construction Work' at RGIPT, Jais Amethi Campus to start the ordered work within 24 hours of

ordering or as specified while ordering. One person will always be available at a specified place to receive the order other than work force. Spare Material/ Machinery/equipment may be required to be stored by the contractor within or outside the Campus to Start the work within 24 hours of ordering or as specified.

10. VARIATION IN QUANTITIES:

The estimated of work is of Rs. 70.0 Lakhs per year. However, it may increase/ decrease 100% as per the actual work requirements of Institute. No claim or compensation whatsoever shall be entertained in this regard.

11. AWARD OF WORK:

The work shall be awarded to the eligible bidder whose tender has been found to be technically responsive and who has quoted the lowest overall cost (L1) as per the terms and conditions of the tender document. However, the RGIPT shall not be bound to award the contract to L-1 Bidder.

12. PERIOD OF CONTRACT:

The period of the contract shall be one year including all holidays, Saturdays & Sundays from the date of L.O.I. The contractor should inform in writing to renew the contract prior to four months of expiry of contract period if he intends to continue the same rates and conditions after completion of contract period. Decision of Competent Authority -RGIPT to allow or not allow for extension of the contract will be final and binding. Contractor will have no right of renewal of the contract.

13. LIQUIDATED DAMAGES:

Shall be 0.5% of the work order amount per week subject to the maximum of 10% of each order value.

14. RUNNING ACCOUNT BILL:

The contractor shall prepare and submit the running account bills showing quantities supplied and executed item wise in 2 copies. The bills along with required documents shall be submitted on

monthly basis, failing which the bills cannot be considered unless the reasons for delay or non-payment are specified. Measurement will be done only on the completion of the work. The contractor has to obtain the User certificate for satisfactory completion of the work as per the Institute's format before raising any Invoice.

15. SECURITY DEPOSIT:

The successful tenderer shall submit additional Initial Performance security of 5% of Contract Value in case EMD was submitted. The EMD submitted in this case will also be converted to performance security 5% of the contract value has to be submitted as performance security in form of DD/Bank Guarantee in favor of, Rajiv Gandhi Institute of Petroleum Technology, Jais, Amethi Campus within 10 days of award of work.

- An Agreement on Rs 100 stamp paper will be required to be executed within 10 days of issue of LOI
 and if the contractor fails to get the agreement done within 10 days or within the extended time as
 granted by RGIPT, Jais, Amethi Campus then the Work awarded/ LOI issued will be deemed as
 Terminated.
- Retention money 5% shall be deducted from each Running Account Bill of contractor. The Security
 deposit/ retention money shall be released after the satisfactory completion of defects liability period
 of the respective work. In general, which will be 6 months from the date of completion of respective
 works if no other date us mentioned in the work order.
- If a successful tenderer fails to commence the work within 3 days from the date of issue of Work order, the Institute may reject the award of work and get the work done by engaging another agency at the risk and cost of the contractor.

16.TESTING OF MATERIALS:

Samples of various materials required for testing shall be provided free of charge by the Contractor. Testing charges if any shall be borne by the contractor. All other expenditure required to be incurred for taking the samples; conveyance, packing etc. shall be borne by the contractor himself.

- a) Regular mandatory test and any additional tests if required, shall be carried out in accordance with the procedure laid down in IS / as directed by Engineer-in-Charge by the contractor at his own cost.
- b) The testing charges, including the cost of materials to be tested and all other incidental charges such as carriage to the testing laboratory etc., shall be borne entirely by the Contractor and the quoted rate shall be deemed to be inclusive of the same.
- c) The Contractor may specifically note that the testing shall be done in Govt. / Govt. (NABL) approved laboratory only.

17. INSPECTION AND TESTING:

RGIPT or its authorized representatives shall have full power to inspect the work or examine the material. Acceptance of any material shall in no way relieve the contractor of his responsibility for meeting the requirements of the specifications. The contractor shall afford and procure for the RGIPT every facility and assistance to carry out such inspection/ tests. The cost of any special tests and/or analysis not called for in this specification shall be borne by the contractor.

- The Contractor will use Raw materials as approved by Engineer-In-Charge RGIPT, Jais, Amethi Campus. And shall keep manufacturer Test certificate of the material used (wherever applicable)
- All works generally conform to relevant I.S. Code. Any work that does not conform to the Applicable I.S. code shall be redone at the cost of contractors.

18. **SAMPLES:**

Test Samples of raw material as per the Instruction of the Engineer In charge will be prepared by the contractors and same to be tested as per code of practice at the cost of contractor as directed by Engineer-In-Charge.

It shall be the responsibility of the contractor to submit samples of raw material to be used in the execution of the awarded work and any other items as decided by the owner. One such approved sample each shall be kept with the owner and at site for future reference.

19. **SUB-STANDARD MATERIALS:**

Any material rejected by the RGIPT, Jais, Amethi shall be removed from the site within 48 hours of issue of instructions to this effect by the owner. Failing this, RGIPT shall have rights to get these removed at the cost of the contractor and the contractor shall have no claim whatsoever in this regard.

20. **SPECIFICATION:**

Contractor shall perform any new construction work in accordance with the latest CPWD Specifications/BOQ Specifications and as per the direction of the Engineer in charge.

22. SAFETY PRECAUTIONS:

Safe means of access shall be provided to all working platforms and other working places. Every ladder shall be securely fixed. Adequate precautions shall be taken to prevent danger from electrical equipment. No materials on any of the sites shall be so stocked or placed as to cause danger or inconvenience to worker, RGIPT Staff, RGIPT Students or any person of the public. The Contractor

shall provide all necessary fencing and lights to protect public from accidents and shall be bound to bear expenses of defense of every suit, action or other proceedings at law that may be brought by any person for injury sustained owing to neglect of the above precautions against the contractor or RGIPT and to pay any damage and costs which may with the consent of the Contractor be paid to compromise any claim by any such person. All workers should wear Safety helmet, Safety Shoes, Fluorescent jacket, and Safety Belt (If required) during the execution of the work.

NOTE: All scaffolds, ladders, First Aid Equipment's/ Machines and other safety devices mentioned or described herein shall be maintained in a safe condition and no scaffold, ladder or equipment shall be altered or removed while it is in use. Adequate washing facilities shall be provided at or near places of work. Necessary warning sign boards in Red/White paint, with proper lighting arrangements for nights are to be provided by the Contractor at his cost, as approved by the Engineer-in-Charge at prominent locations. The arrangements for providing and maintaining all such safety and labour welfare measures etc., shall be done at the Contractor's own cost and expenses.

Apart from the above if the contractor is bound or required to observe any other safety requirement under law or work ethics, he shall strictly observe and follow the same.

- i. If any extra item crops up during the work (Other than that given in the Work Order), the rate for such item shall be computed as per rates of CPWD/ DSR-2023 with the same percentage above or below as is quoted by the Contractor in the Price Bid).
- ii. Rates for items where the rate is not available in DSR-2023 shall be derived from the similar item of the nearest DSR. If not available in the nearest DSR then in the nearest District Schedule of Rates issued by the Uttar Pradesh PWD department. If the item is not found in the DSR and District Schedule of rates, then the Rate from the nearest available Schedule of rates of any Central/ Uttar Pradesh Government Department Shall be considered with whatever latest applicable Cost index of the department plus or minus (If any as per relevant Circular from the department) on the schedule of rates considered.
- iii. If direct working out is not possible as mentioned in i) & ii) above, the contractor shall be paid based on the actual cost of material and labor cost plus 15% towards profit, supervision, overhead establishment, plants, machinery, etc. as decided by the Competent Authority.
- iv. In the case of substituted items (items that are taken up with partial substitution or in lieu of items of work in the contract), the rate for the agreement item (to be substituted) and substituted item shall also be determined in the manner as mentioned in the following para:
- a. If the market rate for the substituted item so determined is more than the market rate of the agreement item (to be substituted), the rate payable to the contractor for the substituted item shall be the rate for the agreement item (to be substituted) so increased to the extent of the difference between the market rates of the substituted item and the agreement item (to be substituted).

b. If the market rate for the substituted item so determined is less than the market rate of the agreement item (to be substituted), the rate payable to the contractor for the substituted item shall be the rate for the agreement item (to be substituted) so decreased to the extent of the difference between the market rates of the substituted item and the agreement item (to be substituted).


