- External edge finishing and walkway formation.
- Provision for water inlet, outlet, and drainage arrangement.

b). Water Fountain System

- Installation of decorative one water fountains with appropriate pump.
- Electrical wiring, switches, and control panel for automatic operation.
- Decorative LED lighting around the pond perimeter and within fountain.
- Testing and commissioning of the complete system.

c). Materials & Labour

- All materials (cement, sand, aggregates, tiles, pipes, electrical accessories, lighting, fountain nozzles, etc.) to be of standard quality and ISI marked.
